Itinerary (Subject to change)

March 14 - 23, 2026

Day 1: Saturday, March 14, 2026: Depart the US

The day has arrived! We will depart Minneapolis (MSP) on an overnight journey to Greece.

Day 2: Sunday, March 15, 2026: Arrive in Thessaloniki

Today we arrive in Greece at Thessaloniki Airport (SKG). Upon arrival, we will be greeted by our guide and/or driver, and we will make our way to our hotel. Overnight Thessaloniki. Holiday Inn or similar. B, D.

Day 3: Monday, March 16, 2026: Kavala, Phillipi, Thessaloniki

The Apostle Paul first made landfall on the European continent at Neapolis, which is today called Kavala. We will drive to Kavala, where we will see the port and a mural dedicated to Paul's arrival. After leaving Neapolis, Paul went to Phillipi where he baptized Lydia and was imprisoned until an earthquake broke his prison open. We too will traverse the Macedonian countryside to Phillipi, where we will visit Lydia's Spring, the agora, the site of the bema, and the prison where Paul was held. Overnight Thessaloniki. Holiday Inn or similar. B,D.

Day 4: Tuesday, March 17, 2026: Veria, Meteora

When Paul left Thessalonica he went to Berea, where he preached to a receptive audience who searched the Scriptures to see if what he was saying was true. We will visit Berea (now called Veria), including a monument to Paul's ministry to the Bereans. We will then drive to Meteora where we will visit the Meteora Monasteries, which are perched high on rocky cliffs. Overnight Meteora. Amalia Kalambaka or similar. B, D.

Day 5: Wednesday, March 18, 2026: Athens

Today we drive to Athens. Time permitting, we will enjoy free time in Athens. Overnight Athens. Athens Avenue or similar. B, D.

Day 6: Thursday, March 19, 2026: Corinth, Athens

We visit Corinth, where Paul lived for an extended period of time. It was to the church at Corinth that Paul wrote 1 and 2 Corinthians. We will see the Fountain of Peirene, the bema of Gallio (where Paul was tried), and the pavement inscription mentioning Erastus. Back in Athens we visit Mars Hill, where Paul famously preached in Acts 17. We will also visit the Parthenon. Overnight Athens. Athens Avenue or similar. B, D.

Day 7: Friday, March 20, 2026: Mykonos

Today we will head to the port of Athens and board our ship. We depart Athens. In the evening our ship will call at Mykonos, an island famous for its whitewashed walls, narrow cobblestone streets, sandy beaches, and windmills. Overnight aboard ship. B, L, D.

Day 8: Saturday, March 21, 2026: Ephesus, Patmos

Today our ship will call at the Turkish port of Kusadasi. We will transfer to the nearby site of ancient Ephesus. The ancient city of Ephesus was a bustling port town of approximately 250,000 inhabitants. The church at Ephesus was one of the Seven Churches of Revelation, and Paul spent a significant amount of time here. Back on board the ship, we will make our way to Patmos, where the Apostle John was exiled, and where he received the visions that now constitute the book of Revelation. Overnight aboard ship. B, L, D.

Day 9: Sunday, March 22, 2026: Santorini

Today our ship calls all day at the port of Santorini. We will enjoy this island, known for its magnificent views and whitewashed buildings clinging to the sides of cliffs, at leisure. Overnight aboard ship. B, L, D.

Day 10: Monday, March 23, 2026: Depart for Home

Today we will arrive back in Athens, disembark our ship, head to the airport, and begin our journey home. Later today we will arrive back in Minneapolis (MSP). B.

Itineraries: Itineraries are prepared and scheduled in advance according to the best information available at the time and are subject to change by the date of the trip.

Pricing: Christian Expedition, Inc. reserves the right to adjust pricing should the following occur: (1) Rise in Airfare due to higher fuel costs, etc. (2) Rise in ground costs due to increases in hotel charges, bus fares, fees, taxes and other costs due to the fluctuating value of the U.S. dollar against foreign currency.

Deposits and final payments: A deposit of \$450.00 per person is required to hold your reservation of which \$200 is non-refundable (may be refundable under travel insurance conditions). Final payment is due 60 days prior to the departure date. Payment can be made by credit card or check. Call (877) 234-3002 to make a credit card payment.

Cancellation fees: For cancellations received less than 90 days prior to the original departure date (even in the case of postponement), the initial deposit of \$450 plus any non-recoverable expenses associated with your reservation incurred by CE will be non-refundable. These expenses may include, but are not limited to, charges imposed by the airlines, hotels, and bus companies, the cost of labor associated with the servicing of your reservation, and the costs assessed for the use of our reservation system, as determined or estimated by CE. Please note that the amount may vary with each trip and the vendors we work with. CE retains the exclusive right to cancel or postpone any trip up to the departure date. If a trip is cancelled by CE all funds received will be returned within 10 business days. If a trip is postponed by CE the cancellation fees enumerated above will remain in effect.
